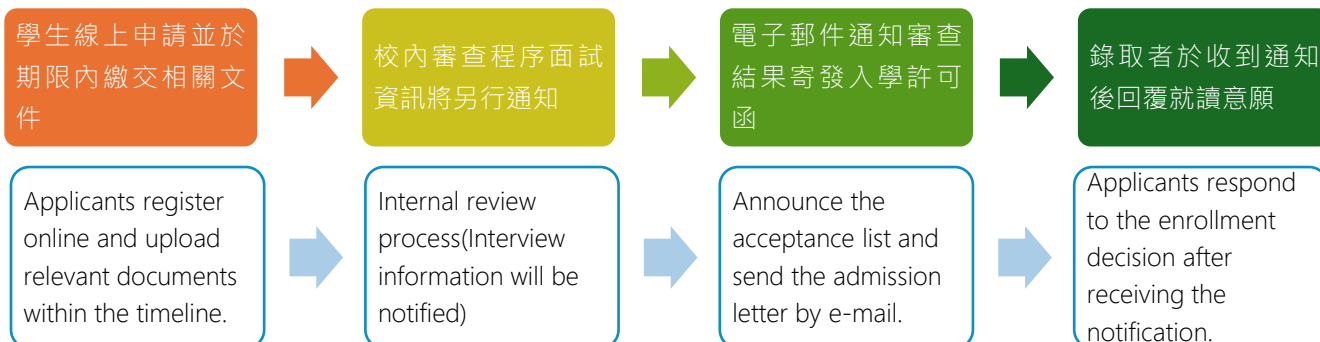

參、申請資格 Admission Requirements

外國學生申請資格須遵守及符合教育部「外國學生來臺就學辦法」、「入學大學同等學力認定標準」、「專科以上學校維護外國學生受教權益應行注意事項」及「國立暨南國際大學外國學生入學招生規定」之規定。

Applicant eligibility must comply and meet with the “Regulations Regarding International Students Undertaking Studies in Taiwan”, “Standards for Recognition of Equivalent Educational Levels for University Admission”, “Guidelines for Ensuring the Educational Rights and Interests of Foreign Students in Colleges and Universities” of the Ministry of Education and “National Chi Nan University Admission Regulations for International Students”.

一、須符合下列身份資格之一者，始具備外國學生申請入學之資格：

(一) 具外國國籍且未曾具有中華民國國籍，符合下列規定者，得依本辦法規定申請入學：

1. 未曾以僑生身分在臺就學。
2. 未於申請入學當學年度依僑生回國就學及輔導辦法經海外聯合招生委員會分發。

Applicant Eligibility:

A person of foreign nationality who has never held Republic of China (“R.O.C.”) nationality and who meets the following requirements is permitted to apply for admission to an educational institution, in accordance with the provisions of these Regulations:

- I. The person has never undertaken studies in Taiwan as an overseas Chinese student.
- II. The person has not been given a placement in the current academic year by the University Entrance Committee for Overseas Chinese Students in accordance with the Regulations Regarding Study and Counseling Assistance for Overseas Chinese Students in Taiwan.

(二) 具外國國籍並符合下列規定，且最近連續居留海外六年以上者，亦得依本辦法規定申請入學：

1. 申請時兼具中華民國國籍者，應自始未曾在臺設有戶籍。
2. 申請前曾兼具中華民國國籍，於申請時已不具中華民國國籍者，應自內政部許可喪失中華民國國籍之日起至申請時已滿八年。
3. 前二款均應符合前項第一款及第二款規定。

A person of foreign nationality who meets the following requirements and who in the immediate past has resided overseas continuously for at least six years is also permitted to apply for admission to an educational institution, in accordance with these Regulations. However, a person who plans to apply to study in a university department of medicine, dentistry, or Chinese medicine must have resided overseas continuously for at least eight years.

- I. A person who at the time of their application also holds dual R.O.C. nationality shall have never had household registration in Taiwan.
- II. A person who before the time of their application also held dual R.O.C. nationality but no longer does at the time of their application shall have renounced their R.O.C. nationality with the approval of the Ministry of the Interior on a date at least eight full years before making their application.
- III. A person referred to in either of the preceding two subparagraphs shall meet the requirements stipulated in Subparagraph 1 and Subparagraph 2 of the previous paragraph.

- (三) 具外國國籍，兼具香港或澳門永久居留資格，且未曾在臺設有戶籍，申請時於香港、澳門或海外連續居留滿六年以上者。

An applicant of foreign nationality, who is eligible for permanent residence in Hong Kong or Macao, who has never had household registration in Taiwan, and who at the time of their application has resided in Hong Kong, Macao, or elsewhere overseas continuously for at least six years may apply for admission in accordance with the provisions of these Regulations.

- (四) 曾為大陸地區人民具外國國籍且未曾在臺設有戶籍，申請時已連續居留海外六年以上者。

A person who was formerly from the Mainland Area and who has foreign nationality and has never had household registration in Taiwan, and who at the time of their application has resided overseas continuously for at least six years may apply for admission to an educational institution.

- (五) 除國際專修部、新南向國際產學合作專班及招生法令另有規定之班別外，應依授課語言明定入學語言能力門檻；需具有華語文能力者，其華語文能力測驗（TOCFL）應達 A2（含）級以上，需具有英語文能力者，其英語文能力測驗應達 CEFR B1（含）級以上，始得申請。

Applicant eligibility except for the International Foundation Program and International Programs of Industry-Academia Collaboration in Taiwan, the language proficiency threshold for admission should be clearly determined according to the language of instruction; those who need to have Chinese language proficiency, their Chinese Language Proficiency Test (TOCFL) Should reach A2 (included) level or above, and those who need to have English proficiency, their English proficiency test should reach CEFR B1 (included) level or above.

二、須符合修讀各級學位之入學資格：

- (一) 符合我國教育部採認之高中、大學或獨立學院畢業：

申請學士班者需具國外高中畢業學歷；申請碩士班者需具大學畢業學歷；申請博士班者需具碩士畢業學歷。

- (二) 具有與我國學制相當之同等學力資格者。

- (三) 外國學生申請入學本校學歷採認，除依我國「外國學生來臺就學辦法」規定辦理，並應符合以下規定：

1. 持大陸地區學歷：應依我國「大陸地區學歷採認辦法規定辦理」。
2. 持香港或澳門學歷：應依我國「香港澳門學歷檢覈及採認辦法規定」辦理。
3. 持同等學力申請入學者，同等學力認定標準應符合我國教育部公告之「入學大學同等學力認定標準」。

Requirements to apply for a program:

- I. To apply for a bachelor' s program, a high school diploma is required. To apply for a master' s program a bachelor' s diploma is required. To apply for a doctoral program master' s diploma is required. Diplomas must be issued by schools recognized by the R.O.C. Ministry of Education.
- II. If there is no diploma, applicants must hold equivalent qualifications for undergraduate or graduate study.
- III. The assessment and recognition of foreign academic credentials should be subject to the MOE Regulations Regarding International Students Undertaking Studies in Taiwan as well as the following rules:

- (I) Academic credentials from the Mainland Area: The MOE Regulations Regarding the Assessment and Recognition of Academic Credentials for Mainland Area should apply.
- (II) Academic credentials from Hong Kong or Macau: The MOE Regulations Governing the Examination and Recognition of Educational Records from Hong Kong and Macao should apply.
- (III) The assessment and recognition of academic credentials at an adequate level of education should be conducted in accordance with the MOE Standards for Standards for Recognition of Equivalent Educational Levels for University Admission.

The foreign high school, college, or university where an applicant earned his/her graduation certificate, diploma, or academic credentials should be officially recognized by the Ministry of Education, R.O.C. Please visit the Database for the Reference List of Foreign Universities for more details.

四、欲申請就讀學士班者，須未曾在我國以外國學生身分申請並完成高中學校學程。

Applicants who have completed secondary education in the Republic of China are not eligible to apply to bachelor's degree programs as foreign students.

五、須未曾遭入學學校以操行、學業成績不及格或因犯刑事案件經判刑確定致遭退學者。

International students who are expelled from any university/college after admission due to any misconduct, poor academic performance or a conviction under the Criminal Code may not thereafter reapply.

六、須未曾因違反本校校規情節重大而遭本校註銷選讀資格者。

Applicants who have been previously disqualified from participating in National Chi Nan University courses because of any violation of university regulations are ineligible to apply.

七、須符合招生簡章各系所個別要求之申請條件。

Applicants must meet all individual departmental requirements.

八、如違反上述任一條件之申請者，經查證屬實後，撤銷入學資格、開除學籍或本校畢業資格，且不發給任何學歷證明。

An applicant who is found to have violated any of the aforesaid rules should be disqualified from admission or have his/her student status forfeited, or the degree diploma issued should be revoked. Providence University reserves the right to not issue any certificate to such a student.

International Applications for International Foundation Program must be received between **【Fall Semester】 April 1, 2026 to June 5, 2026; 【Spring Semester】 August 17, 2026 to October 16, 2026.** Applications received after the deadline will not be processed.

陸、獎助學金及學雜費減免申請

Scholarship and Tuition Reduction

國際專修部外國學生於申請本校入學許可時，得依「國立暨南國際大學外國學生獎勵實施要點」一併提出學雜費減免申請。(申請表於附錄 7)

International Foundation Program Applicants must submit all the required documents listed in the International Student Scholarship Guidelines with all other application documents. (Appendix 7)

- 一、本校保留更新外國學生獎學金規定之權利。

National Chi Nan University reserves the right to revise Scholarship Policy.

- 二、報讀本校國際專修部之學生，可向學校申請學雜費減半或減免，審查方式與學士班申請人相同。

Students enrolled in our International Foundation Program may apply for a 50% reduction or waiver of tuition and fees. The evaluation process will be identical to that for applicants to the bachelor's degree program.

- 三、外國學生得依相關規定申請政府獎學金(如：外交部台灣獎學金

International students who wish to apply for scholarships awarded by organizations outside of NCNU must follow the guidelines and requirements of each granting organization. Having been awarded a Taiwanese government scholarship or another institution's scholarship does not guarantee admission into National Chi Nan University. Admission into National Chi Nan University does not guarantee a scholarship or Tuition Reduction. Admissions and scholarship awards are evaluated by different committees of National Chi Nan University.

- 五、上述獎助學金均不得重複受領。

The same scholarship will not be awarded to the same individual more than once.

柒、收費標準

山水埔里 美麗暨大 NCNU - Scenic Location and Landscape

臺灣是個呈南北狹長型的海島，面積約有 3.6 萬平方公里(14,400 平方英哩)，位於亞洲大陸東南方、太平洋西岸東亞島弧間，北臨日本、琉球群島，南接菲律賓群島，是往來亞洲各地的樞紐；位處亞熱帶的臺灣，四季如春、物產豐富，人民認真勤奮、樂觀積極，並曾創造經濟繁榮、和平民主、多樣物產以及科技成就等等許多的奇蹟。

Located in the West Pacific, the beautiful island of Taiwan was named “Formosa” by the Portuguese and “The Green Island” by the Taiwanese. Taiwan is an island situated between the tropical zone and the subtropical zone. With the weather like spring all year round, it is an area known for its plentiful agricultural products, diligent and enthusiastic people who have created numerous miracles including economic prosperity, democracy, diverse farm commodities and scientific and technological excellence, which have drawn wide attention worldwide.

南投縣位於臺灣中央，是唯一不濱臨海洋的縣市，長久以來，南投縣就以好山好水著稱，境內有臺灣最高山—玉山，有臺灣最長的溪流—濁水溪，也有臺灣最大的高山湖泊—日月潭等等。在南投縣，春天可以到日月潭遊湖賞花、到鹿谷喝茶，夏天可以到山林避暑、到溪谷戲水，秋天可以到奧萬大賞楓、到廬山泡溫泉，冬天則可以到合歡山賞雪或者到信義鄉賞梅；南投縣的美麗與精彩，渾然天成、豐富多樣，因此有「東方瑞士」的美稱。

There are 21 major cities in Taiwan. Nantou County is situated right in the middle of Taiwan and is the only hilly county that does not have a coastline. For a long time, Nantou has been known for its beautiful mountains and pure water. Nantou County is also the area that contains Taiwan's highest mountain, Yushan, its longest river, the Choshui River, and its biggest high mountain lake, Sun Moon Lake. In spring, people often enjoy lake cruising and flower viewing on Sun Moon Lake and tea-drinking in Luku. During the summertime, it's excellent to go away for a summer trip and stay in a mountain forest or enjoy the water in the valley. In autumn, a trip to the maples in Auwanta and hot-spring bathing in Lushan are also popular. In winter, enjoy a trip to the snow in Mount Hohuan or to the plum orchards in Hsinyi. The beauty of Nantou is as diverse as nature itself. The beauty of Taiwan has earned it the good name, “The Eastern Switzerland”.

埔里鎮位於台灣的地理中心，隸屬於南投縣，居縣境北部，地形上四面環山，是屬於盆地地形，同時是濁水溪和北港溪間盆地群中，位置最北，面積最大的一個盆地，高度約在海拔 380 公尺到 700 公尺之間。埔里的人口大約 86,000 多人，總共 23,417 戶，行政轄區共分成 33 里，是一個中型的鄉鎮。

Situated in the northern side of Nantou County, Puli Township is categorized as the most representative town out of thirteen towns in Nantou due to its unique farm products and rich culture. The fine weather and pure water contribute to the many beautiful nicknames of Puli such as “The Last Pure Land in Western Taiwan”, “The Backyard of Taichung”, “The Lotus Tower”, “Town of Butterflies”, “City of Flowers”, “Township of Cultural Center” and “The Treasure House of Anthropology”.

埔里鎮一年到頭都舉辦著各類型的文化活動，包括傳統的廟會活動、民俗陣頭，以及藝文展覽、音樂演奏、劇團歌舞等等，國際知名的朱宗慶打擊樂團及林懷民舞蹈團等都曾經多次來埔里演出。另外，埔里的花卉、茭白筍、百香果、紹興酒、紅甘蔗、天然漆及手工宣紙等特產，也都聞名中外，為埔里帶來許多經濟面的繁榮，加上在埔里鎮有全臺年紀最高的茄苳樹，有東南亞最大的佛教道場—中台禪寺，還有世界三大昆蟲博物館之一的木生昆蟲世界

等等，充分展現出小鎮上人文薈萃與物產豐饒之特色。

The general impression that people have about Puli is its wealth of talents and abundant farm products. In this small town, all year round there are all kinds of cultural activities such as traditional temple fairs, folk shows, cultural exhibitions, musical shows, and song and dance troupes. The internationally renowned Ju Percussion and Lin Hwai-min's Cloud Gate dance group have performed several times in Puli. Contributing to Puli's economic prosperity are its plentiful resources of flowers and plants, water bamboo, passion fruit, Shaoxing wine, brown sugar cane, natural lacquer and hand-made calligraphy paper, for which Puli is world renowned. Puli also boasts the oldest Qie Dong tree, the largest Buddhist douching, Chung Tai Chan Monastery, and one of the largest three insect museums in the world, Mu Sheng Insectarium. Many people consider it a blessing to live in Puli, lending to its international status as one of the finest cities in the world to live in.

NCNU offers courses such as Introduction to Southeast Asia and International Trendy to reflect that Southeast Asia is one of the research focuses. To cultivate students' service spirit, NCNU offers two-semester zero point five credit public service course. In order to help students to learn languages and promote overseas students' English and Chinese proficiency, this university offers multimedia courses and has developed "Chinese classroom of network multimedia" to promote efficiency and interest that students have in language studies and that they may continue their language learning even when they enter the workforce. Furthermore, NCNU cooperates with local resources to offer PE courses such as light boat and archery in hope to enrich students' life.

- 二、本要點所需經費來源為教育部專案補助計畫或本校學生獎助學金項目。
- 三、本要點適用對象為預定就讀本校及在本校就學之外國學生，且符合下列資格者：
 - (一) 符合「國立暨南國際大學外國學生入學辦法」第四條規定者，或依本校與外國學校共同簽署雙聯學制來校攻讀學位之外國學生。
 - (二) 申請人須符合下列規定：
 1. 申請學士班者，其標準由申請就讀之本校系所認定並決定是否予以推薦；已就讀本校學士班者，其前一學期學業平均成績應達八十分以上或本校系所主管推薦並敘明理由，且行為表現無不良紀錄者。申請碩、博士班者，其原學校畢業成績應達GPA3.0以上或相當成績，其標準由申請就讀之本校系所認定並決定是否予以推薦；已就讀本校碩、博士班者，其前一學期學業平均成績應達八十分以上或本校系所主管推薦並敘明理由，且行為表現無不良紀錄者。研究生於撰寫論文期間無修課成績者，得以指導教授推薦信作為申請依據。
 2. 申請國際專修部並經審查錄取者，且其後每年應達續領資格。
 3. 申請全英碩士學位學程並經審查錄取者，且其後每學期應達續領資格。
 4. 有關外國學生獎勵申請人之成績標準及綜合表現，各系所可另訂之。
 5. 已就讀本校「中文授課課程」之在學學生，需通過華語文能力基礎級（TOCFL Level 2）以上、教育部華語能力測驗考試聽力及閱讀A2以上成績或相當等級之國際通用中文能力證明。
 6. 學生如有不符上列條件但情況特殊者，系所應召開審查會議，檢附會議決議資料（含外國學生獎學金申請書、外國學生成績追蹤輔導措施表、學生成績單）於每年四月三十日、十月三十日前推薦提請國際及兩岸事務會議討論之。
- (三) 有下列情形之一者，不得申請：

1. 曾被撤銷本獎勵者。

2. 曾觸犯我國法律情節重大者或違反本校學生獎懲辦法申誡以上者。

3. 在校內外有全職工作、持有工作居留證或永久居留證者，不得申請本獎勵。

(四) 依本要點規定申請本獎勵者，同一申請人，同一教育階段，以補助一次為限。

四、本校外國學生獎勵分為獎助學金及學雜費（含學分費）減免。

獎助學金之額度、名額、核給期間及受獎年限規定如下：

(一) 獎助學金額度：

1. 碩士班：校級獎助學金每名每月新臺幣三千至五千元整。

2. 全英碩士學位學程：校級獎助學金每名每月新臺幣六千元整。

3. 博士班：校級獎助學金每名每月新臺幣六千至八千元整。

4. 前項獎助學金之外，國際及兩岸事務處、院、系所、指導教授得視情形，另外增加獎助學金之金額。

(二) 獎勵名額：依當年度經費而定。如當年度獎助學金經費用罄，即不再受理申請。

(三) 獎勵核給期間：全英碩士學位學程至多核給二年，核給期間內，前一學期未達續領標準者，次學期不予核發；其他外國學生每次核給一學期。獎助學金經核定後，除入學時，自當月起補助外，每學期共補助六個月，第一學期為八月至次年一月，第二學期為二月至七月。在校生需依申請資格，每學期重新提出申請。

(四) 受獎年限：碩士班至多二年、博士班至多四年。

學雜費（含學分費）減免上限：分為部分減免（同本校一般生收費標準）及全額減免。

國際專修部學生就讀期間學雜費全額減免，升讀大一旦繳交華語文能力測驗（TOCFL）聽力與閱讀基礎級A2以上證明者，學雜費全額減免，升讀大二且繳交華語文能力測驗

（TOCFL）之聽力與閱讀進階級B1以上證明者，學雜費全額減免，升讀大三前則依本要點第三點第二款第一目之學士班規定每學期重新提出申請。學士班學雜費減免，期間至多減免四年。碩士班學雜費基數至多減免二年，學分費每學期至多減免十二學分。全英碩士學位學程學雜費基數至多減免二年，學分費每學期至多減免十二學分，住宿費全免（四人一間）至多減免二年。博士班學雜費基數至多減免四年，學分費每學期至多減免十二學分。

五、本獎勵之受理申請時間：新生預定申請就讀本校者，請備齊入學申請文件，做為審查標準，並應於申請本校入學許可時一併提出。全英碩士學位學程受獎者入學後需簽署聲明書，且學期學業平均成績達八十五分以上，次學期得自動續領。外國學生入學後須於每年四月十五日至四月三十日及十月十五日起至十月三十日向國際處申請下一學期獎勵。申請文件如下：

(一) 申請表。

(二) 歷年成績單正本（新生入學後，尚未有第一學期成績者得免繳）。

(三) 系所主管或指導教授推薦信1封。

(四) 中文授課系所之學生:需繳交華語文能力基礎級(TOCFL Level 2)以上證書、教育部華語能力測驗考試聽力及閱讀A2以上成績或相當等級之國際通用中文能力證明。

(五) 其它有助審查之資料(如課外活動、競賽獲獎證明、論文發表等各類獎勵或研究成果，無則免附)。

(六) 有效期限內之居留證正反面影本

六、審核原則：

(一) 國際簽約學校推薦者，得優先獎勵。

(二) 提出其它有助審查文件者，得酌予加分。

(三) 獲獎名單應由本校國際及兩岸事務會議審核。

七、領取本獎勵者，有義務協助國際及兩岸事務處推動國際學術交流業務，或接受所屬系所安排其擔任教學、行政或研究助理，工作時數及內容由國際及兩岸事務處或各系所規定之。

八、其他注意事項：

(一) 受獎助學生，如經查證有偽造、變造或其他不實之情事者，應撤銷其受獎資格，已領取之獎勵應予追回。

(二) 受獎助學生畢業或退學時起，即不得受領本獎助學金。

(三) 受獎助學生休學期間不得受領本獎助學金，復學時應重新提出申請。

(四) 外國學生已領取我國政府各機關(構)所提供之獎補助者，不得重複領取本獎勵，若受獎助學生同時受領我國政府機關(構)或學校設置之獎補助金，經查證屬實者，除撤銷本獎勵外，並追繳重複領取之每月獎助學金及學雜費(含學分費)。

(五) 受獎助學生倘以交換學生或雙(聯)學位生身分出國就讀，即暫停其獎助學金受獎資格，原受獎期間不得展延。

(六) 受獎助學生除寒暑假外，未經學校及系所許可離開我國境內者，得逕行停發不在境內之每月獎助學金或追償已核發之獎助學金。

(七) 受獎助學生就學期間，若缺、曠課情形嚴重、學業或其他綜合表現不佳，可由各系所主管、指導教授簽請國際處申請停發外國學生每月獎助學金。

(八) 受獎助學生於受獎期間觸犯我國法律或違反本校校規，經國際事務及兩岸事務會議審議後，自處份確定次月起，撤銷其受獎資格。

(九) 受獎助學生於受獎助期間在校內外有全職工作、持有工作居留證或永久居留證者，不得領取本獎勵，違反者應撤銷獎助資格。如有溢領情事，經查證屬實，應繳回已受領之獎勵。

九、本要點經行政會議通過，陳請校長核定後實施。

- I. To encourage international students to pursue studies at National Chi Nan University and to recognize outstanding performance, these “National Chi Nan University Guidelines for Incentives for International Students” (hereinafter referred to as “the Guidelines”) were formulated in accordance with Article 15 of the “Regulations Regarding International Students Undertaking Studies in Taiwan.”
- II. The funding required for the implementation of these Guidelines shall be drawn from the Ministry of Education’s special subsidy programs or the university’s student scholarship and financial aid programs.
- III. These Guidelines apply to international students who plan to enroll at, or are currently enrolled in, the university and who meet the following qualifications:
 - (I) International students who meet the requirements of Article 4 of the “National Chi Nan University Admission Regulations for Foreign Students” or who are pursuing a degree at the university through a dual-degree program jointly established with a foreign institution.
 - (II) The applicant must meet the following requirements:
 1. Applicants to undergraduate programs must meet the standards set by the relevant department, which will determine whether to recommend admission. Current undergraduate students must have achieved an academic average of 80 or above in the previous semester, or be recommended by the department head with justification, and have no record of misconduct.

Applicants to master’s or doctoral programs must have graduated with a GPA of 3.0 or above (or an equivalent score) from their previous institution. The specific standards shall be determined by the relevant department, which will decide whether to recommend admission. Current master’s or doctoral students must have achieved an academic average of 80 or above, or be recommended by the department head with justification, and must have no record of misconduct. Graduate students engaged in thesis writing and who do not

have course grades must submit a recommendation letter from their thesis advisor in lieu of grades.

2. Applicants to International Foundation Program must be admitted through review and must meet renewal requirements annually.
3. Applicants to the English-Taught Master's Program must be admitted through review and must meet renewal requirements each semester.
4. Each department may establish its own standards for evaluating applicants' academic performance and overall qualifications.
5. Current students enrolled in the university's "Chinese-taught programs" must pass the basic level of the Test of Chinese as a Foreign Language (TOCFL Level 2), achieve at least A2 in listening and reading on the Ministry of Education's Chinese Proficiency Test, or hold an equivalent internationally recognized Chinese proficiency certificate.
6. Current students of the university who do not meet the above conditions but have special circumstances must have their case reviewed by the relevant department. The department shall convene a review meeting and submit the meeting's resolution documents (including the International Student Scholarship Application Form, the International Student Academic Progress and Support Measures Form, and the student's transcript) to the International and Cross-Strait Affairs Meeting for discussion before April 30 and October 30 each year.

(III) Applicants who fall under any of the following categories are not eligible to apply:

1. Applicants who have previously had this scholarship revoked.
2. Applicants who have committed serious violations of the laws of the Republic of China (Taiwan) or have received a reprimand or higher penalty under the university's Student Rewards and Punishments Regulations.
3. Applicants who hold full-time employment either on or off-campus, who hold an Alien Resident Certificate (ARC) indicating work as the reason for residence, or who hold an Alien Permanent Resident Certificate (APRC).

(IV) Applicants may receive this scholarship only once per educational level.

IV. Incentives for international students include scholarships and tuition/fee (including credit fee) waivers.

The regulations regarding the amount, number of recipients, duration, and maximum award period of the scholarships are as follows:

(I) Scholarship Amount:

1. Master's Program: NT\$3,000 – NT\$5,000 per month per recipient.

2. **English-Taught Master's Program: NT\$6,000 per month per recipient.**
 3. **Doctoral Program: NT\$6,000 – NT\$8,000 per month per recipient.**
 4. In addition to the above, the Office of International and Cross-Strait Affairs, colleges, departments, or academic advisors may grant additional scholarship amounts as deemed appropriate.
- (II) **Number of Recipients:** Determined based on the budget for the current year. If funds for the year are exhausted, no further applications shall be accepted.
- (III) **Duration of Scholarship:** **Recipients in English-Taught Master's Programs may receive a scholarship for a maximum of 2 years. Recipients who do not meet renewal standards in the previous semester shall not receive an award for the following semester. Scholarships for other international students are granted 1 semester at a time. Once approved, scholarships begin in the first month of enrollment and are provided for 6 months each semester. The first semester covers August to January of the following year, and the second semester covers February to July. Current students must reapply each semester based on the eligibility criteria.**
- (IV) **Maximum Award Duration:** Up to 2 years for master's programs and up to 4 years for doctoral programs.

Tuition and Fee (Credit Fee) Waiver Limits: Waivers are categorized as partial (based on the standard tuition and fees for regular students at the university) or full. For the International Foundation Program, a full tuition and fee waiver during study. Students promoted to the first year of undergraduate study and who submit TOCFL Level 2 (A2 listening and reading) certification receive a full waiver; those promoted to the second year with TOCFL Level 3 or above (B1 listening and reading) also receive a full waiver. Thereafter, undergraduate students must reapply each semester in accordance with the undergraduate program regulations in Section 3, Paragraph 2, Item 1 of these Guidelines. For undergraduate programs, tuition and fee waivers may be granted for up to 4 years. For master's programs, tuition waivers may be granted for up to 2 years, with a maximum credit fee waiver of 12 credits per semester. For English-Taught Master's Programs, tuition waivers may be granted for up to 2 years, with a maximum credit fee waiver of 12 credits per semester. Dormitory fees (quadruple room) are waived for up to 2 years. For doctoral programs, tuition waivers may be granted for up to 4 years, with a maximum credit fee waiver of 12 credits per semester.

- V. **Application Period:** New students must prepare the required admission documents as the basis for evaluation and submit them together with their admission application. **Recipients admitted to the English-Taught Master's Program must sign a declaration upon admission. If they maintain a semester grade average of 85 or above, the scholarship shall automatically continue in the**

following semester. Current international must apply through the Office of International Affairs between April 15 – April 30, or October 15 – October 30 each year for the following semester's scholarship. The required application documents are as follows:

- (I) Application form.
- (II) Original transcripts of all academic years. (New students who have not yet completed their first semester are exempt from submission.)
- (III) One letter of recommendation (students who want to enroll in NCNU can use the same application letter for entrance admission; current students should submit a recommendation letter from their department chair or academic advisor.)
- (IV) **Students enrolled in Chinese-taught programs must submit proof of passing the basic level of the Test of Chinese as a Foreign Language (TOCFL Level 2), results of the TOCFL Speedy Screening with at least A2 in listening and reading in the Ministry of Education's Chinese Proficiency Test, or the equivalent internationally recognized Chinese proficiency certificate.**
- (V) Other supporting documents that may aid in the evaluation process (e.g., certificates of extracurricular activities, competition awards, published papers, or other achievements or research results; if unavailable, they do not need to be submitted.)
- (VI) **Copy of a valid Alien Resident Certificate (both sides).**

VI. Review Principles:

- (I) Applicants recommended by partner institutions with international agreements shall be given priority for the scholarship.
- (II) Applicants who provide additional supporting documents that assist in the evaluation process may receive additional points.
- (III) The final list of recipients shall be reviewed and approved by the university's International and Cross-Strait Affairs Meeting.

VII. Recipients of this award are obligated to assist the Office of International and Cross-Strait Affairs in promoting international academic exchange activities, or to accept assignments from their relevant departments to serve as teaching, administrative, or research assistants. The working hours and duties shall be determined by the Office of International and Cross-Strait Affairs or by the relevant departments.

VIII. Other Notes:

- (I) Recipients found to have engaged in forgery, alteration, or other fraudulent conduct shall have their scholarship revoked, and any disbursed funds must be returned.
- (II) Recipients become ineligible to receive the scholarship upon graduation or withdrawal from

the university.

- (III) Recipients shall not receive the scholarship during a leave of absence and must reapply upon resuming their studies.
 - (IV) International students who are already receiving the Taiwan government scholarship or subsidies are not eligible to receive this scholarship. If it is verified that a student is simultaneously receiving scholarships or subsidies from other government agencies or institutions, this scholarship shall be revoked, and any duplicated monthly scholarship funds and tuition/fee (credit fee) waivers shall be reclaimed.
 - (V) Recipients who study abroad as exchange students or dual/joint degree students shall have their scholarship eligibility suspended during their time abroad, and the original scholarship period shall not be extended.
 - (VI) Except during winter and summer breaks, recipients who leave Taiwan without the permission of both the university and their department, may have their monthly scholarship payments suspended for the period spent outside Taiwan, or may be required to repay any disbursed scholarship funds.
 - (VII) Recipients who have severe absences, truancy, poor academic performance, or unsatisfactory overall performance during their studies may have their monthly scholarship payments suspended upon the recommendation of their department head or academic advisor, with approval by the Office of International Affairs.
 - (VIII) Recipients who violate the laws of Taiwan or the university's regulations during the scholarship period shall have their scholarship eligibility revoked beginning in the month following the finalization of the disciplinary action, as determined by the International and Cross-Strait Affairs Meeting.
 - (IX) Recipients who hold full-time employment on or off campus, hold an Alien Resident Certificate (ARC) indicating work as the reason for residence, or hold an Alien Permanent Resident Certificate (APRC) during the award period are ineligible to receive this scholarship. Any violations shall result in revocation of eligibility, and any disbursed funds shall be repaid by the recipient.
- IX. These guidelines shall be implemented upon approval by the Administrative Meeting and final authorization by the university president.

The above regulations were translated from the original Chinese. In the event of any discrepancies between the two versions, the Chinese version shall prevail.
